By acceptance of the subsequent permit, you hereby release and discharge Tarrant Regional Water District and its agents, and directors, and agree that Tarrant Regional Water District shall not be held liable or responsible for, and shall be indemnified and held harmless by, you, your successors, assigns, and heirs, from and against any and all claims and damages of every kind for injury indirect, to operation, use, or existence, of the improvement which you are requesting permission to construct on the District's Reservoir, or from any act of the District, its agents, or directors, including the operation BASED IN WHOLE OR IN PART ON THE ALLEGED NEGLIGENCE OR OTHER TORT OF TARRANT REGIONAL WATER DISTRICT OR ITS AGENTS OR DIRECTORS, THE PARTIES HERETO INTENDING TO THE EXPRESS NEGLIGENCE DOCTRINE.

This release and indemnification shall survive termination or expiration of the permit.
